Purpose

To operate an ABC System in the City of Sanford in conformance with North Carolina's uniform system of control over the sale, purchase, transportation, manufacture, consumption, and possession of alcoholic beverages.

Appointment Authority

The Sanford ABC board was created in Chapter 105, S.L. 1961, and amended in S.L. 1969-470. It was a three-member board appointed by the City of Sanford Board of Aldermen with three year terms until June 18, 2024, when City Council approved expanding board membership by two members, to become a five-member board as provided by Ordinance 2024-046 (G.S. 18B-700).

Authority of Board

The ABC Board is an autonomous Board operating under the specific statutory authorities cited in N.C.G.S. The Board may authorize entering into contracts on behalf of the Board. No loans shall be contracted on behalf of the Board, no evidences of the indebtedness shall be issued in its name unless authorized via resolution of the Board. All checks or drafts issued in the name of the Board shall be signed by the officer or officers determined by resolution of the Board. The Committee Chairperson shall be designated by the Sanford City Council annually.
