**Purpose**

**Appointment Authority**

Six members: five members and one alternate appointed by the City Council to serve three-year staggered terms; one member and one alternate appointed by the Lee County Commissioners from the City's extra-territorial planning jurisdiction to serve three-year staggered terms, as provided by Ordinance No. 2004-22 adopted June 30, 2004.

**Advisory Board**

The Planning Board is an advisory board required by the General Statutes.

Planning Board meets with the City Council every third Tuesday of each month at 6:00 p.m.; other times on a called basis. Public hearings are held in the Council Chambers; business meetings are held in the West End Conference Room, City Hall.
